





<p>When should my child self-isolate or miss school?</p> 	 NO	<ul style="list-style-type: none"> <input type="checkbox"/> All children MUST attend school unless they are ill or have tested positive for Covid. <input type="checkbox"/> From 16th August 2021, children under 18 (or double-vaccinated adults) do not need to self-isolate or miss school if a member of their household or a contact, has Covid. <input type="checkbox"/> Instead, they will need to book a PCR test but can continue coming to school so long as they have no symptoms whilst they await the result of the test.
	 YES	<ul style="list-style-type: none"> <input type="checkbox"/> If your child develops Covid symptoms at home, they should <u>stay at home</u> and should book a PCR test), NOT a Lateral Flow test. <input type="checkbox"/> If your child develops Covid symptoms at school, they will be sent home and you should book them a PCR test. <input type="checkbox"/> If your child tests positive for Covid, they will need to self-isolate. The rest of the household does not need to self-isolate if they are under 18 or fully vaccinated – but instead should book a PCR test.

Rapidly Rising Community Transmission

- No current Covid cases have been recorded at school, but...
 - Cases of Covid are rising rapidly in the community causing disruption to other local schools.
 - S Gos Public Health / Public Health England issue warnings of expected local/
national infection wave
- Ventilation of classrooms increased & handwashing supervised.
 - Large indoor public performance audience numbers reduced.
 - Staff-room capacity is reduced.
 - Whole-school assemblies are replaced with Key Stage assemblies.
 - Clinically Vulnerable staff meet with Line Managers to review their individual risk assessment & discuss additional protection (e.g. use of face coverings, reduction in movement between classes/ groups).

A single child tests Positive

- A single child tests positive for Covid in a class.
 - There are fewer than 5 cases in the year group.
 - No other year groups are affected.
- The child self-isolates for 10 days. Remote learning will be provided if they are well enough to complete it as outlined. The parents of the child are contacted directly by NHS Track and Trace to establish likely contacts.
 - Likely contacts will be contacted by NHS
 - Track & Trace and advised to book at PCR Test. The school will contact parents to advise this if close contacts are known.
 - **Children do not need to miss school or selfisolate whilst they wait for the result of the PCR test unless they have Covid Symptoms.**



5 children or staff within a year group test positive within 10 days of each other.

OR

3 children or staff in a single Class/ Club (or Resource Base) within 10 days.

- There have been 5 cases of Covid across a year group within 10 days which could mean that Covid is spreading within that group of children.

- **As above for each positive case.**
- The school will discuss the outbreak with South Glos Public Health and agree strengthening protective measures for 10 school days, including:
 - Re-introducing staff face masks for corridors & communal areas.
 - Adapting, Limiting or postponing indoor sporting events, trips, open days and performances.
 - Reverting to video-link Assemblies in classrooms.
 - Reducing the amount of classes staff work across.
 - Resuming twice-weekly Staff Lateral flow testing.



Covid cases continue to increase rapidly within a 10 day period.

- Despite the measures indicated above, Covid cases within the school continue to rise within a 10 day period with multiple classes and staff affected, suggesting that Covid is spreading widely throughout the school.

- Incident Management Team meeting held between the school and S Glos Public Health to agree further measures, for a further 10 school days, including possibly:
 - Re-introducing class bubbles.
 - Reverting to class-based school lunches.
 - Limiting all non-essential visitors to school.
 - Postponing all non-essential events.
 - **Re-introducing remote learning for individual classes for 10 school days considered, as outlined.**

The school will inform parents of any changes to Covid measures should these be needed.

Appendix A: Close mixing (examples from Contingency Framework)

Identifying a group that is likely to have mixed closely will be different for each setting. Below are some examples.

For schools, this could include:

- a form group or subject class
- a friendship group mixing at breaktimes
- a sports team
- a group in an after-school activity

For out-of-school settings, this could include:

- a private tutor or coach offering one-to-one tuition to a child, or to multiple children at the same time
- staff and children taking part in the same class or activity session together
